

# Division 22 Standards for Public Elementary and Secondary Schools

## 2019-20 Assurances Report

By November 1 of each year, school district superintendents are required by [OAR 581-022-2305: Operating Policies and Procedures](#) to report to their school board the district's standing with respect to all of the Standards for Public Elementary and Secondary Schools as set out in Oregon Administrative Rules Chapter 581, Division 22. For the 2019-20 school year, the State Board of Education adopted [OAR 581-022-0103: State Standards for the 2019-20 School Year](#). This rule established a streamlined set of Division 22 standards in effect for the 2019-20 school year, accommodating for the shift to emergency distance learning in response to the COVID-19 pandemic. For the 2019-20 school year, school districts are required to report on the Division 22 standards included in OAR 581-022-0103; any standard not included in this rule is waived for the 2019-2020 school year.

Below is a summary of Drewsey's compliance with each of the standards included in [OAR 581-0103: State Standards for the 2019-20 School Year](#). For each standard reported as out of compliance (there were no areas out of compliance), Drewsey has provided an explanation of why the school district was out of compliance and the school district's proposed corrective action plan to come into compliance by the beginning of the 2021-22 school year.

A Distance Learning for All plan was developed and implemented as a result of school closures in March, 2020. Following guidance from ODE, all students were provided their education through packets, teacher connections and some limited online opportunities.

## Special Education for Children with Disabilities

Drewsey School District contracts with Harney Education Service District for Special Education Services for the 2019-2020 year provided by Gayle Mackey. Gayle works effectively with the teacher and any student requiring specially designed instruction. Shannon Criss provides oversight and supervision of Special Education Service delivery.

## Emergent Bilinguals

Drewsey School District had no bilingual students.

## Talented and Gifted

Drewsey School District has a process for identification of students who qualify as talented and gifted. Students who are identified are served with a specially designed program. There are currently no students identified as talented and gifted.

Drewsey School District has trained staff and board members and updated board policies in regards to student safety as it pertains to reporting child abuse pursuant to ORS 419B.010.

## Personnel

There is one teacher employed at Drewsey School and she holds a valid Oregon license. One educational assistant meets Oregon Administrative Rules for employment. Administrative and specialist services are contracted through Harney Education Service District. .

## Fingerprinting of Subject Individuals in Positions not Requiring Licensure as Teachers, Administrators, Personnel Specialists, School Nurses

All individuals in positions not requiring licensure have complied with the requirements for fingerprinting and are in compliance with OAR 581-021-0500.
